Tuition Payment Policy and Rates for 2023/2024

Payment options:

Annual Plan: Payment in full upon registration or by September 1, 2023.
Payment in full by September 1 will receive a 5% discount when paying via ACH or check.

Monthly (x10) plan: Payment made in 10 (ten) installments due one month in advance. First installment is due upon registration.

By completing registration, you understand and agree to pay your child's tuition for the entire year (September 2023 - June 2024) and confirm that you understand and accept the policies listed below.

- Every person taking a class at Metrowest Dance Academy must be a registered student with a completed Registration Form on file. Registration is in effect from August 1 to July 31 of the following year.
- Non-refundable registration fee is \$35, maximum \$60 per family.
- All tuition payments may be made using bank transfer (ACH) or credit card.
- A non-refundable tuition deposit of 10% (first month's fees) is due at the time of registration to ensure your child's enrollment for next year. The amount of the deposit will be deducted from your remaining tuition balance.
- Enrollment is on-going, and tuition is pro-rated from the date of student's commencement.
- Second and subsequent siblings will receive a discount of 10%. The discount will be applied to siblings dancing the least hours.
- A \$10 fee will be charged for all late payments. Monthly payments are due on the 1st of the month and late fees will be charged if the payment is not received by 5th of the month. If payments are more than 30 days past due, your child will not be allowed to attend classes until payments are made.
- Returned checks will be subject to a \$35 fee.

- Classes missed due to illness/injury may be made up by participating in classes selected from the current schedule. Email info@metrowestdance.com to schedule.
- Additional fees that may be incurred by participants could include performance and examination fees. Any and all fees paid to Metrowest Dance Academy are non-refundable.
- Tuition is non-refundable. However, credits for training at Metrowest Dance Academy are available in case of a serious illness/injury or other unforeseen circumstances.
- Metrowest Dance Academy reserves the right to combine classes, change times, provide substitute or replacement instructors, or cancel class when deemed necessary. Every effort will be made to reschedule a canceled class and notify students of changes as soon as possible. These decisions will be made by the studio Director.
- The class schedule is subject to change. Within the first 2 weeks of the semester classes may be canceled or combined according to demand. Classes may also be added due to demand.
- The office must be notified in writing when a student withdraws from a class. One month's notice is required. Refunds or deductions are not permitted.

COVID-19 RELATED POLICIES:

Metrowest Dance Academy follows the Centers of Disease Control and Prevention (CDC) guidelines regarding COVID-19. The CDC recommends that instead of quarantining if you were exposed to COVID-19, you wear a high-quality mask for 10 days and get tested on day 5.

Regardless of vaccination status, you should isolate from others when you have COVID-19. You should also isolate if you are sick and suspect that you have COVID-19, but do not yet have test results. If your results are positive, you need to stay home for at least 5 days and isolate from others in your home. You are the most infectious during this time. If after 5 days you are fever-free for 24 hours without using medication, your symptoms are improving, or never had symptoms, then you may end isolation. If your results are negative, you can end your isolation.

You should wear a high-quality mask through day 10 to protect those who are more susceptible to COVID-19.
